This was the second of two conversations. I had asked for the file in order to speak accurately about this case.

Mr. Reinbolt explained that the creation date is correct for this sequence of yoga movements and that the author has based his career on this particular compilation, teaching other yoga teachers as shown on the videotape deposited.

He explained that the compilation was first fixed in text form, published in a book, and duly registered in the C.O. under TX 179-160 in 1979. Now he wants a registration which states a claim in "compilation and arrangement of movements." He explained that the ownership of the rights in the compilation and the book are the same. He would prefer a new, basic registration because of impending legal action.

In consultation with Linda Gill (PA Section Head) after the telephone call, we agreed that the appropriate and correct means to show Mr. Choudhury's claim in the compilation was a supplemental registration on Form CA. First, the ownership of the compilation and the text is the same. Secondly, the compilation and the text are inseparable elements, unlike songs which contain words and music or a children's book which contains both text and artwork.

Also, Mr. Reinbolt should be made aware that the original registration's EDR probably pre-dates the infringing action and that the additional benefits of Sections 411 and 412 are secured because the registration was timely.

The basis of your registration is the compilation of exercises shown on the videotape. This compilation, you explained, was fixed in text form and published early in 1979 as "Bikram's Beginning Yoga Class." The copyright claim was registered in this Office under number TX 179-160 and it names Bikram Choudhury as author and claimant.

Washington D.C. 20559-6000 In our conversation, you said that you thought it was necessary to have a registration on Form PA for the compilation of exercises in order to pursue legal action because of the type of authorship being claimed. This is not the case. As a practical matter, a claim in any copyrightable work of authorship may be registered on any standard form with the exception of sound recordings and certain special categories (e.g. vessel hulls and mask works).

You also said that the ownership of the copyright in the compilation was the same as the ownership of the book Given the previous registration's unlimited claim in text and the fact that the compilation and the text in which the compilation is fixed are owned by the same claimant and are inseparable elements, an additional basic registration is not appropriate. You may, however, further refine the basic registration made in 1979 by adding the term "compilation of exercises" or "selection and arrangement of exercises" to the nature of authorship line of the basic registration by using a Form CA.

This supplemental registration will augment but not supercede the previous registration, and a supplemental registration will not stand on its own apart from the basic registration. We will cross-reference the supplemental registration to the original registration only if the CA is signed by the claimant named on the original or that claimant's authorized agent. Moreover, there is no deposit requirement for Form CA. This is because the work has already been deposited with the original registration, and the purpose of the CA application is to augment or correct information given on the application. See Circular 8.

The filing fee for Form CA is \$100. We can apply the current \$30 filing fee towards the CA and the remaining \$70 would be drawn from your deposit account when we

Dear Mr. Reinbolt:

I consulted the head of the Performing Arts Section (Linda Gill) about this case and she came to the same conclusion we discussed. A supplemental registration on Form CA is the appropriate means to show your client's claim in our records and we would not accept another basic registration. She also pointed out the additional benefits of using the 1979 registration as a foundation of your client's claim, and you will find them in sections 410-412 of the statute.

The reference to "inseparability" in the third paragraph of my letter bears a little more explanation. Yes, the compilation of movements may be fixed in different formats such as text or videotape, but the form in which it was presented to us for registration was text. Unlike a song with easily separable words and music, the text and the compilation of movements described by the words are inseparable, rather like a musical arrangement (orchestration, harmonization) where the arrangement cannot be separated from the music on which it is based.
